## Release and Waiver of Liability and Indemnity Agreement

In consideration of being permitted to enter the IVRRC Taylorsville Junior Rodeo and to participate in the activities for any purpose, including but not limited to observation, use of facilities or equipment or participation in any way, the undersigned, on behalf of his/her minor child (*name of participant*) \_\_\_\_\_ and any personal representatives, heirs, and next of kin, hereby acknowledges, agrees and represents that he/she has, or immediately upon entering will, inspect such premises and facilities and equipment. It is further warranted that such entry into the IVRRC Taylorsville Junior Rodeo and performance of the foregoing activities, for observation, participation or use of any premises, facilities and equipment constitute an acknowledgement that such premises and all facilities and equipment thereon have been inspected and that the undersigned finds and accepts same as being safe and reasonably suited for the purpose of such observation or use.

In further consideration of being permitted to enter the IVRRC Taylorsville Junior Rodeo for any purpose including, but not limited to observation, use of facilities or equipment or participation in any way, the undersigned agrees to the following:

1. The undersigned hereby releases, waives, discharges and covenants not to sue the IVRRC Taylorsville Junior Rodeo, its members, officers, employees and agents, for any loss or damage, and any claim or demands therefore on account of injury to the person or property or anything resulting in death of the aforesaid minor child of the undersigned, whether caused by the negligence of the releases or otherwise while the aforesaid minor child of the undersigned is in, upon, or about the premises or any facilities or equipment therein or thereon.
2. The undersigned hereby agrees to indemnify and hold harmless the releases and each of them from any loss, liability, damage or cost they may incur due to the presence of the aforesaid minor child of the undersigned in, upon or about the IVRRC premises or in any way observing or using any facilities or equipment of the IVRRC either caused by the negligence of the releases or otherwise.
3. The undersigned hereby assumes full responsibility for any risk of bodily injury, death or property damage due to the negligence of releases or otherwise while the aforesaid minor child of the undersigned is in, about or using any facilities or equipment of the IVRRC Taylorsville Junior Rodeo and/or while said minor is using the premise or any facilities or equipment therein or thereon.

The undersigned further expressly agrees that the foregoing releases, waiver and indemnity agreement is intended to be as broad and inclusive as is permitted by the law of the state of California and that if any portion thereof is held invalid, it is agreed that the balance shall, notwithstanding, continue in full legal force and effect. The undersigned has read and voluntarily signs the release and waiver of liability and indemnity agreement, and further agrees that no oral representations, statements or inducements apart for the foregoing written agreement have been made.
